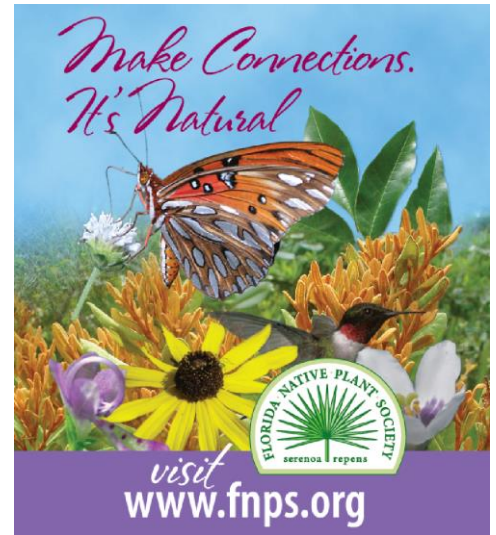


Showcase the Beauty Of Native Plants



Florida Native Plant Society LANDSCAPE AWARDS



CATEGORIES AND CRITERIA:

- **Residential Single Family - Entry fee: \$45**
 - 1) 75% or more of the parcel must contain native plants
 - 2) Minimum 2-year grow-in period before submittal
 - 3) No plants listed on the Florida Exotic Pest Plant Council's Category I and II lists
- **Residential Multi-Family (including subdivisions) - Entry fee: \$130**
 - 1) 60% or more of the parcel must contain native plants
 - 2) Minimum 2-year grow-in period before submittal
 - 3) No plants listed on the Florida Exotic Pest Plant Council's Category I and II lists
 - 4) Educational component for Institutional category only (your choice of signage, tours, media article, etc.)
- **Commercial (retail, office), - Industrial – or - Transportation (streetscapes, roadways, medians, right-of-ways) - Entry fee: \$160**
 - 1) 60% or more of the parcel must contain native plants
 - 2) Minimum 2-year grow-in period before submittal
 - 3) No plants listed on the Florida Exotic Pest Plant Council's Category I and II lists
 - 4) Educational component for Institutional category only (your choice of signage, tours, media article, etc.)
- **Institutional (government entities, public sites, churches, schools)**
 - **If designed in house: No entry fee. Professionally designed: \$160**
 - 1) 60% or more of the parcel must contain native plants
 - 2) Minimum 2-year grow-in period before submittal
 - 3) No plants listed on the Florida Exotic Pest Plant Council's Category I and II lists
 - 4) Educational component for Institutional category only (your choice of signage, tours, media article, etc.)
- **Restoration (private or public projects that restore or enhance existing Florida native plant communities) - No entry fee**
- **Butterfly or Wildflower Garden - No entry fee**
 - 1) 100% of the project must contain native plants
 - 1) Minimum 1-year grow-in period before submittal
 - 2) No plants listed on the Florida Exotic Pest Plant Council's Category I and II lists
 - 3) Educational component (signage, tours, media article, etc.)
 - 4) **Plant species must occur naturally in that region of the state**
 - 5) Provide information on the origin of the site (soils, historical hydrology, etc.)
 - 6) Provide comments regarding the success of pollinator/wildlife attraction to the garden

SUBMITTAL REQUIREMENTS:

- 1) Planting Plan (hand sketch or electronic)
- 2) Plant List containing botanical names and quantities
- 3) Photographs (High resolution, in color, 10 maximum, showing overall and close-ups with descriptive captions). Before and after photos are greatly appreciated.
- 4) Completed application form on following page
- 5) Check made payable to FNPS Landscape Awards in the amount of your entry fee
- 6) Narrative (2 pages maximum, 12-point text and one-inch margins) including:
 - Statement of pre-existing conditions
 - On-site preservation of existing native plants (if applicable)
 - Native landscape design concepts, goals and species diversity
 - Relationship to original native plant community on the site
 - Plant establishment activities and long term maintenance plans
 - Creative solutions to significant challenges (if applicable)
 - Description of educational component (if applicable)
