Richard Moyroud briefly discussed appreciation letters for Dan Austin and Richard Gaskalla. David Drylie brought up the idea of renaming a common name on our regulated list for Dan. Request for Bryan to draft a letter of appreciation for Dan Austin.

A total of four Endangered and Threatened Native Flora Conservation Grant Applications were received this year for consideration. All four were received timely, and all met the minimum eligibility requirements for consideration. All were assigned an application number. A copy of each application was forwarded to council members for review prior to this meeting. The four applications were evaluated and ranked by council members.

The opportunity for grant applicants & past grant recipients to present on their ongoing and future conservation activities were offered to those present.

Eric Menges presented details outlining conservation efforts, and the past year's programs, as well as ongoing and future efforts. A copy of the 2014-2015 Final Report was provided to EPAC members.

Suzanne Koptur made a motion to not delist Echinodorus floridanus as non-native until further reviewed during next meeting. Jack Stout seconded. Motion passed.

Discussion on new funding source for conservation and management of plant species with lowest scores (0-5) focusing on those most rare. The list will be titled "The Most Critically Endangered Plants for Resource and Conservation Management". A report of these plants scoring 0-5 will be prepared and sent to council members by Bryan Benson.

Discussion on matching funding for grants with a joint effort with wildlife foundation, plant societies, private parties.

The Council discussed the importance of a Council representative at the US Fish and Wildlife Meetings. Susanne Koptur will represent for the Council and report to the council. This could result in additional funding.

The Council discussed the benefits of a license tag to support research and education on endangered plants and considered the difficulties of having one approved.

Continued discussion of outreach opportunities for EPAC and native plant conservation. Some ideas include bookmarks with photos and information, coffee cups, or website enhancement. Looking into FDACS Marketing to assist. The Division of Plant Industry Botany section will work with our Public Information Office to see about building lesson plans for Ag in Classroom for endangered plants. Our grant recipients may have lessons already in place that we can leverage. Bryan Benson will see what the grant recipients have to share.

Council recommends changing of the common name of *Stylisma abdita*, included in 5B-40 from hidden stylisma to Austin's dawn-flower, in honor Dan Austin's contributions to the Endangerd Plant Advisory Council.

David Drylie made a motion to change common name of Sylisma abadita to Austin's dawn-flower. Motion seconded by Jack Stout. Motion passed.

### **Election of Officers**

Suzanne Koptur made a motion to maintain the current officers (Mr. Richard Moyroud, Chair, and Dr. Loran Anderson, Vice Chair). Motion was seconded David Drylie. Motion passed.

#### **Comments from Council and Interested Parties**

Review for next meeting *Justicia cooleyi*, a listed species. Recent research suggests this species might not be native. Bok Tower staff members are conducting genetic research to help resolve the issue. Council will review information next year.

Discussion on spelling updates for common and scientific names. Patti will work on cleaning up for our next rule update.

Registered nursery in panhandle question selling listed plants that may be on the regulated plant index
